RESOLUTION NO. 2024 - 03

TO PROVIDE FOR COOPERATION BETWEEN AND AMONG THE BOARDS OF COUNTY COMMISSIONERS, CITY AND VILLAGE COUNCILS, AND TOWNSHIP TRUSTEES WITHIN THE MIAMI VALLEY REGION OF SOUTHWESTERN OHIO IN THE MAINTENANCE AND OPERATION OF A REGIONAL PLANNING COMMISSION.

BE IT RESOLVED BY the Village of Lewisburg, Preble County, Ohio, that said unit of local government does hereby enter into an agreement and pledge its support and cooperation to and with other Boards of County Commissioners, City and Village Councils, and Township Trustees, within the Miami Valley Region of southwestern Ohio, and such other member governments as may from time to time similarly desire to cooperate in the maintenance and operation of the Miami Valley Regional Planning Commission.

BE IT FURTHER RESOLVED THAT, in compliance with and as a part of the adoption of this Resolution, the Village of Lewisburg, Preble County, Ohio, does also agree to maintain its membership in said Miami Valley Regional Planning Commission, in compliance with the Constitution and Bylaws of the Miami Valley Regional Planning Commission.

BE IT FURTHER RESOLVED THAT any member government may withdraw its maintenance and cooperation hereunder at any time by a resolution to do so, and delivering a certified copy thereof, approved by the legislative body of said city, village, township, or county, to the Director of the Miami Valley Regional Planning Commission, at least three hundred sixty-five (365) days prior to the actual date of withdrawal.

Such withdrawal shall be effective on the three hundred sixty-sixth (366th) day from the date the Director acknowledges receipt of the certified copy of the resolution to withdraw. The presentation of the resolution to withdraw shall not relieve the withdrawing party of its obligations to contribute its share of the cost for the year in which the withdrawal occurs, nor shall it withdraw its area from the study area of the Miami Valley Regional Planning Commission during the year of withdrawal.

BE IT FURTHER RESOLVED THAT these terms of maintenance and cooperation shall take effect immediately upon their adoption and certification by the legislative body of said city, village, township, or county.

BE IT FURTHER RESOLVED THAT the Director of the Miami Valley Regional Planning Commission shall, upon receipt of the duly adopted and certified resolution, thereafter, include said political subdivision as a full member in the Miami Valley Regional Planning Commission with all rights and privileges thereto.

BE IT FURTHER RESOLVED THAT the Village of Lewisburg, Preble County, Ohio shall not be bound by this Agreement if there is not sufficient participation from the area's political subdivisions to make the existence of the Miami Valley Regional Planning Commission feasible.

This Resolution shall be effective from and after the earliest period allowed by law.
