## A RESOLUTION AUTHORIZING THE SUBMITTAL OF APPLICATIONS FOR FEDERAL IIJA FUNDS THROUGH THE MIAMI VALLEY REGIONAL PLANNING COMMISSION

Whereas, the Miami Valley Regional Planning Commission (MVRPC) has solicited local government entities to submit new transportation projects for funding consideration through the RTPO Capital Improvement Program;

And Whereas, the Village of Lewisburg has committed to a timely project development schedule;

**And Whereas**, the Village of Lewisburg will commit the necessary resources to support the estimated local cost portion of the projects, and the following list of projects will be submitted to MVRPC, shown in order of the Village of Lewisburg's priority from number 1 to 1:

1. S. Commerce Street Rehabilitation - Estimated Local Share \$66,643.00.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF LEWISBURG, PREBLE COUNTY, OHIO, AS FOLLOWS:

<u>Section 1.</u> This Resolution shall serve to authorize the transmittal and submittal of applications for the following transportation projects to MVRPC for funding consideration through the RTPO Capital Improvement Program: S. Commerce Street Rehabilitation.

<u>Section 2.</u> The Municipal Manager is hereby authorized to sign on behalf of the Village the application for funds as referred to in Section I of this Resolution.

<u>Section 3.</u> The Municipal Manager is hereby directed and authorized to take or cause to be taken all other action necessary and proper to secure the funding sought by the application referred to herein, and provide any additional information sought by reviewing agencies during the time the application is under review. The Municipal Manager is further directed and authorized to cause compliance with all reporting requirements required by the Miami Valley Regional Planning Commission (MVRPC) as required as part of the funding process.

<u>Section 4.</u> Upon application approval, the Village hereby states its commitment to the local contribution for the project as identified in these applications, including local contribution of costs exceeding the current estimates or subsequent revised estimates as accepted by the MVRPC.

<u>Section 5.</u> It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including, but not limited to Section 121.22 of the Ohio Revised Code.
