Manager Sewert also provided updates on: needing to schedule a Ways and Means Committee Meeting soon, meeting with the Soccer Association regarding their proposed name/signs for the soccer fields, upcoming ribbon cutting ceremony at Panther Prep, upcoming Ohio Rural Water Association training session being held in Lewisburg, work being done on the Bicentennial Square Building, the Preble County Chamber Expo on April 8<sup>th</sup> & 9<sup>th</sup>, and a 4-H event on June 18<sup>th</sup>.
